Competition Requirements

This show will be conducted and judged in accordance with the **United States Rules for Working Equitation**, Revision 7 dated 1 January 2024. The rules can be found at the following site: <https://usawe.org/competitions/rules/>. **It is the competitor's responsibility to read and understand the rules prior to the competition.**

All competitors in USAWE-licensed shows must be USAWE members. Non-members may only show as *hors concours* (schooling rides) and pay a \$50 non-member fee per show.

All competing horses must be recorded with USAWE in advance of the show. A one-time fee of \$30 per horse includes lifetime performance tracking.

Riders with permanent disabilities can apply for a Dispensation Certificate that approves the use of adaptive equipment and other allowances.

A single horse and rider team is allowed to show in only one level. A horse may be entered twice in a competition if ridden by two different riders and in different levels. Exception: Two youths or one youth and one adult can share the same horse if competing in Level 1. See Rulebook, Section 1.8.

In USAWE-licensed competitions, a rider must compete in the classification designated on their USAWE membership application, i.e.,

- **Youth:** Riders between the ages of 7 and 17 as of January 1.
- **Amateur:** Non-professional riders.
- **Open:** Open to all riders. Professional riders may only compete in the **Open** division.

See USAWE Competition Manual, section 2.3 for further explanation.

Riders must be correctly attired and horses properly presented in accordance with the U.S. Rules for Working Equitation. Show Management may, at its discretion, bar any person or horse from entering the arena if not suitably presented.

Payment Policy

- **Entry forms and Stabling forms are electronic for this show.** When the form is submitted, the competitor will be redirected to PayPal to make their payment.
- **No entry may show unless it is paid in full.**
- If the event is canceled, a full refund minus the \$40 office fee will be issued within 14 days of cancellation.
- If a competitor withdraws prior to the closing date, they must notify the Show Manager in writing. A full refund minus the office fee will be sent within 14 days of notification.
- Entries are non-refundable after the closing date. Show management, however, may be able to provide a refund minus the office fee on a case-by-case basis under one of the following conditions:
 - Withdrawal of a rider or horse is due to an injury, illness, or death. The withdrawal must be accompanied by a veterinarian's or doctor's certificate.
 - There is a waitlist, and the show manager is able to replace your entry.

Entry Procedures

- A separate entry form must be completed for each horse-rider combination. The entry and stabling forms are electronic. The Entry Form for Dream Park #2 may be found [HERE](#). A .pdf version of the entry form is attached to the end of this prize list for those who choose to mail their entries in. Checks should be made payable to Working Equitation East.
- An entry form is not valid unless it is fully completed and has all the proper signatures, membership numbers, and horse information. Each entry form must have the original signatures of Riders/Handlers and Owner/Agent. An adult must sign for any junior rider.
- **Entries must be received by the closing date.** Entries received after the closing date will be assessed a **\$50** late fee and possibly be placed on a waiting list.
- No phone entries will be accepted. Entries are accepted on a first-paid, first-served basis.
- Photocopy of negative **Coggins** test, dated within one year of the end of the show, is required and must be emailed to the Secretary or presented at the time of check-in. Entries without a current (valid through show date) **Coggins** test result will not be allowed to show.
- Any **non-competing horses** must have an entry form sent in and a current negative **Coggins** test must be emailed to the Secretary or presented at the time of check-in.

Prizes/Awards

- Rosettes awarded from 1st thru 5th place in each class for Open, Amateur, and Youth divisions.
- Championship and Reserve Championship rosettes will be awarded to the overall first and second place rider/horse teams in each level/division.
- Awards will be given to the overall High Score for Open, Amateur, and Youth rider/horse team. The High Score will be determined by the average of the team's Dressage and EOH scores.
- Points from this show will count towards the 2024 Working Equitation East Show Series. For more information click [HERE](#).

Stabling Details

- New Jersey State law requires a current **health certificate** for horses arriving from out of state. Your horse cannot be stabled on the grounds without a health certificate.
- Competitors may show out of their trailer. There will be a **\$20 charge/day**.
- **Arrival:** Friday, August 16, 2024, after 12:00 p.m.
- **Departure:** Sunday, August 18, 2024, by 8:00 p.m.
- **Early arrivals/late departures** must be coordinated with and approved by the **Stable Manager** and will be subject to an additional **\$40 charge per stall per night**.
- Emergency contact information must be prominently displayed on all stalls housing an animal, including both cell phone and local contact information.
- Stalls must be bedded. Bedding may be purchased from Dream Park @ \$8/bag. Hay is the responsibility of the competitor.

- **Do not use stalls you have not paid for.**

General Information

- There is a Food Vendor available on the show grounds.
- **WE East** reserves the right to refuse an entry for any reason.
- **WE East**, the **WE East Working Equitation Show**, and **Dream Park** reserve the right to maintain a **Harassment Free Environment** and may remove or refuse entry to any person(s) disrupting the show.
- **Dogs** must be securely tied, caged, in a closed stall, or on a leash at all times while on the show grounds or in the stable area. **No Dogs** allowed in the indoor arena.
- **No smoking** is allowed in the barn areas or in any of the other buildings.

Rules and Regulations

Hold Harmless Clause: Understanding that horse sports may be hazardous and dangerous, even leading to permanent injury or death, each owner, rider, spectator, and other participant assumes any and all risk of loss or injury and agrees to hold harmless, regardless, the horse show personnel and the facility hosting the show. **WE East**, the **WE East Working Equitation Show**, and **Dream Park** will not be responsible for any damage, injury, or loss to persons, horses, or property of exhibitors, spectators, or grooms. All local facility rules must be followed.

Motor Vehicle Operation: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
